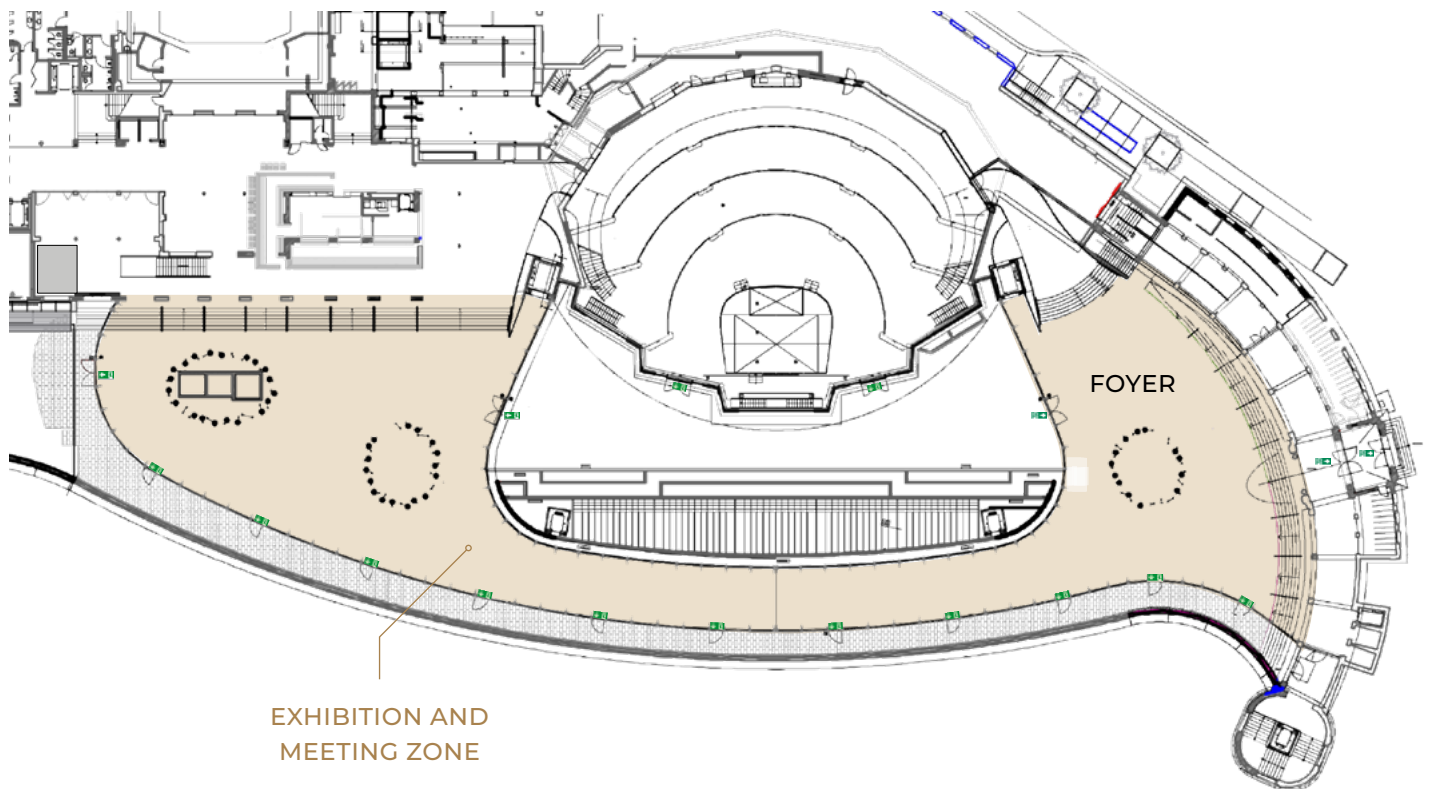

TERMS AND CONDITIONS

1. Scope of application

The following General Terms and Conditions apply to the AVOLA SYMPOSIUM, an event organized by the AVOLA DECLARATION ASSOCIATION.

2. Registration

Event registrations are submitted via the registration platform on the Internet. The registration becomes legally binding only after a confirmation has been sent by e-mail. Only registrations received within the specified registration period can be considered for the event.

3. Implementation

3.1. General terms

By registering, the participant agrees to these General Terms and Conditions as well as to any other safety, access and other implementation regulations issued for the event and undertakes to comply with these as well as with instructions issued by employees of AVOLA (or third parties commissioned by AVOLA). AVOLA reserves the right to replace announced speakers with others and to make necessary changes to the program while preserving the overall character of the event. Compensation or reimbursement of event ticket costs due to such changes is not granted.

3.2. Postponement of the event

If the event is postponed, for whatever reason, the ticket purchased is automatically valid for the postponed date. For refunds or exchanges, the regulations under point 4 apply.

3.3. Discontinuation or cancellation of the event

If the event has to be aborted or cancelled due to force majeure, external influences (demonstrations, violence, threats by third parties, pandemic) or other circumstances for which AVOLA is not responsible, purchased tickets cannot be exchanged or refunded. If the event is cancelled by AVOLA for other reasons, the participant may submit his/her claim for a refund in writing to AVOLA within a period of 30 days after cancellation of the event. The payment already made shall then be refunded in full.

4. Cancellation policy

The following withdrawal and cancellation provisions apply to all registrations:

4.1. Regular participants

Regular participants are persons who have purchased a paid ticket.

- Cancellation up to one month before the event: full refund
- Cancellation up to seven days before the event: refund of 50% of the ticket price
- Cancellation less than seven days before the event: No reimbursement

4.2. Exhibitors

With their registration, tabletop exhibitors agree to a binding contract with the organizer, which includes exhibition space along with two regular conference tickets. The arrangement can

only be booked as a whole. Unused elements of the arrangement will not be reimbursed. The following applies to the booking of a table:

- Cancellation up to three months before the event: full refund
- Cancellation up to one month before the event: 50% refund on the full booking price
- Cancellation less than one month before the event: no refund

4.3. Guests / speakers

For guests of AVOLA (e.g. speakers) and guests invited by partners, withdrawal is possible at any time free of charge.

4.4. Withdrawal formalities

The withdrawal and cancellation policies mentioned in sections 4.1 to 4.3 shall also apply in the event of a participant being prevented from attending due to illness, accident or similar reasons. The declaration of withdrawal must be made in writing or directly in the participant profile on the event platform. The entitlement to a refund is based on the date of receipt of the written notice of cancellation. For Saturdays, Sundays and public holidays, the following working day shall apply.

4.5. Transference

Tickets may be transferred to a third party free of charge up to two weeks before the event. In the event of a change of participant notified less than fourteen days before the event, a processing fee of CHF 50.00 will be charged.

5. Data privacy

Name, company and position, as well as other information voluntarily provided by the participants, will be disclosed on the digital event platform.

6. Multimedia recordings

In the course of the event, AVOLA or third parties commissioned by AVOLA may make image, sound and/or video recordings. These recordings will be used by AVOLA for its own marketing purposes, among others. By participating in the event, the participant agrees to the aforementioned image, sound and/or video recordings and allows AVOLA to use them for subsequent advertising purposes.

7. Exclusion of liability

AVOLA's liability for direct and indirect damages as well as consequential damages incurred by the participant in connection with the organization and implementation of the event is excluded to the extent permitted by law. In any case, liability shall be limited to the amount of the cost of the event ticket.

8. Applicable law and place of jurisdiction

All activities of the event organized by AVOLA and the present terms and conditions shall be governed exclusively by Swiss law. The place of jurisdiction is Lucerne.
